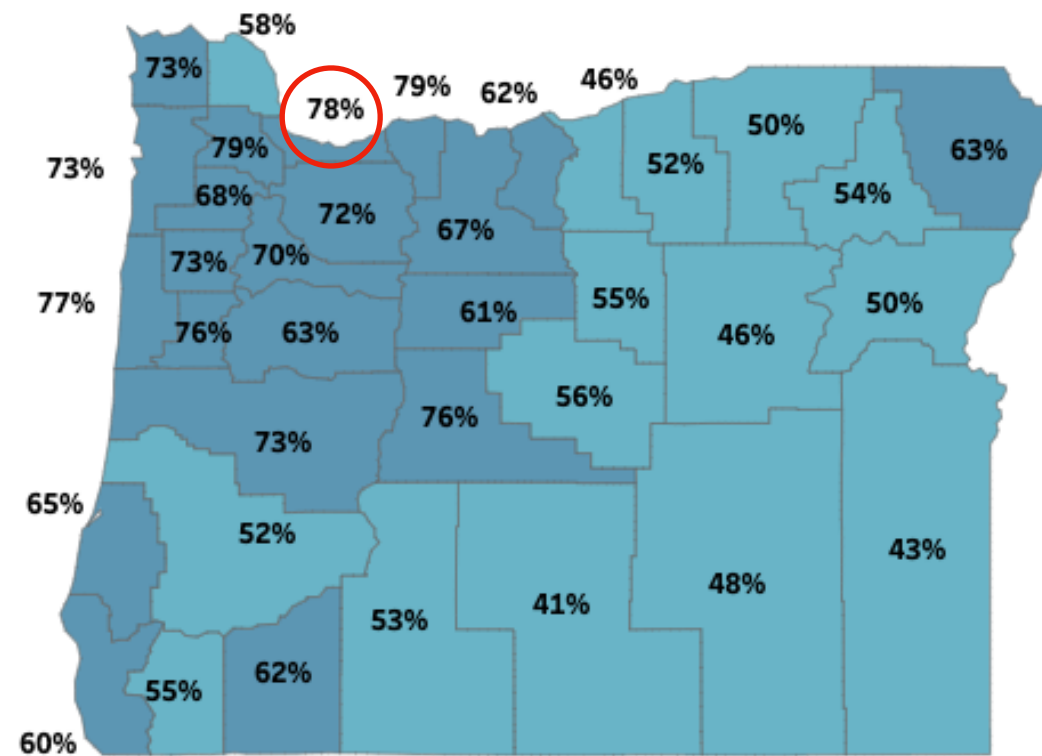

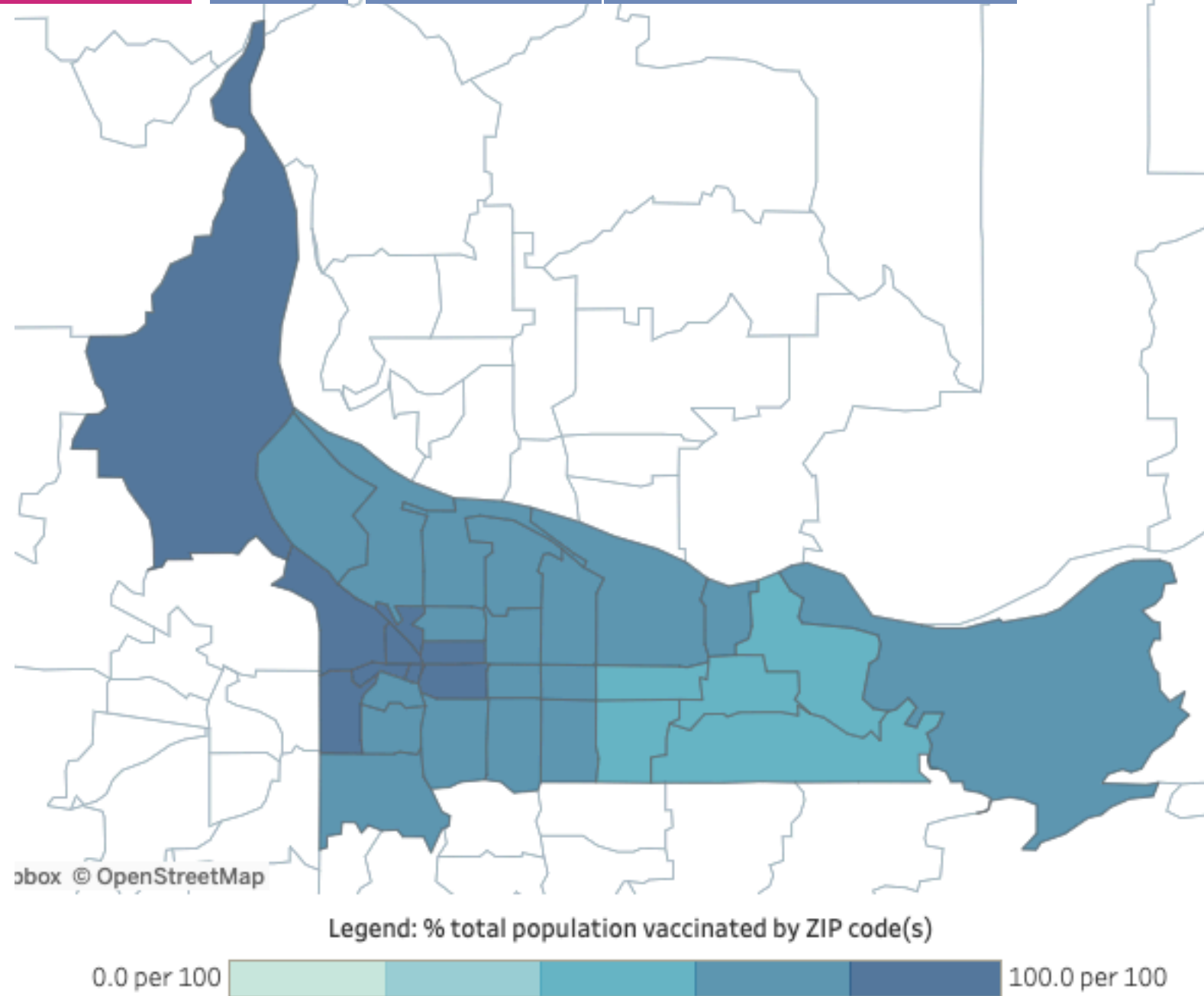

People remaining to receive first dose to reach 80% of each population vaccinated by county and age



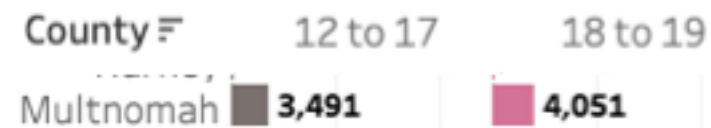

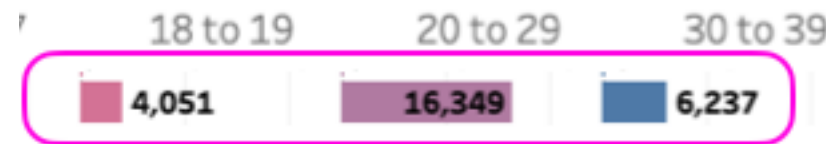

## Federal Level Mandates

### Majority of U.S. employers will implement vaccine mandates

According to a **Willis Towers Watson** poll conducted last month, 52% of the 961 companies surveyed said they'll have at least one vaccine mandate in place by the fourth quarter of 2021, a significant shift since May, when 72% of respondents said they didn't plan to require vaccines. 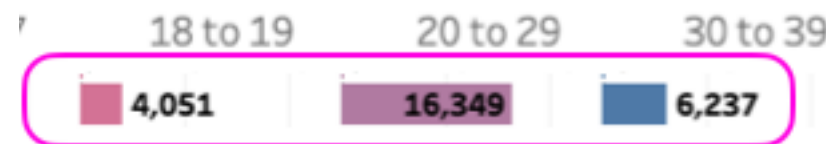

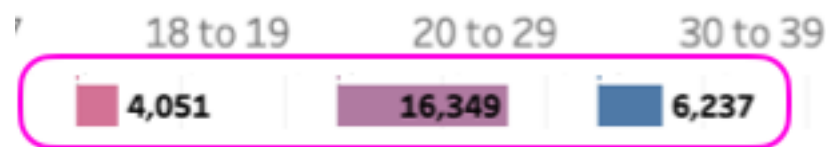

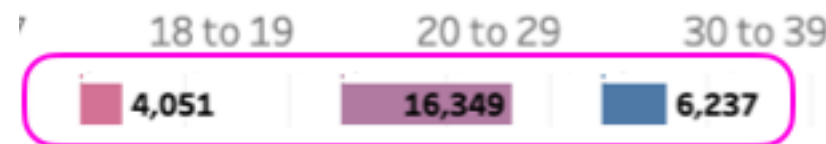
Summary



**Reach them at where they live (#1 priority) in low vaccination zip codes and #2 priority in high vaccination neighborhoods in the Central City where youths go to be entertained.  
#2 priority is restaurants, bars, sex clubs, nightclubs and entertainment venues.**

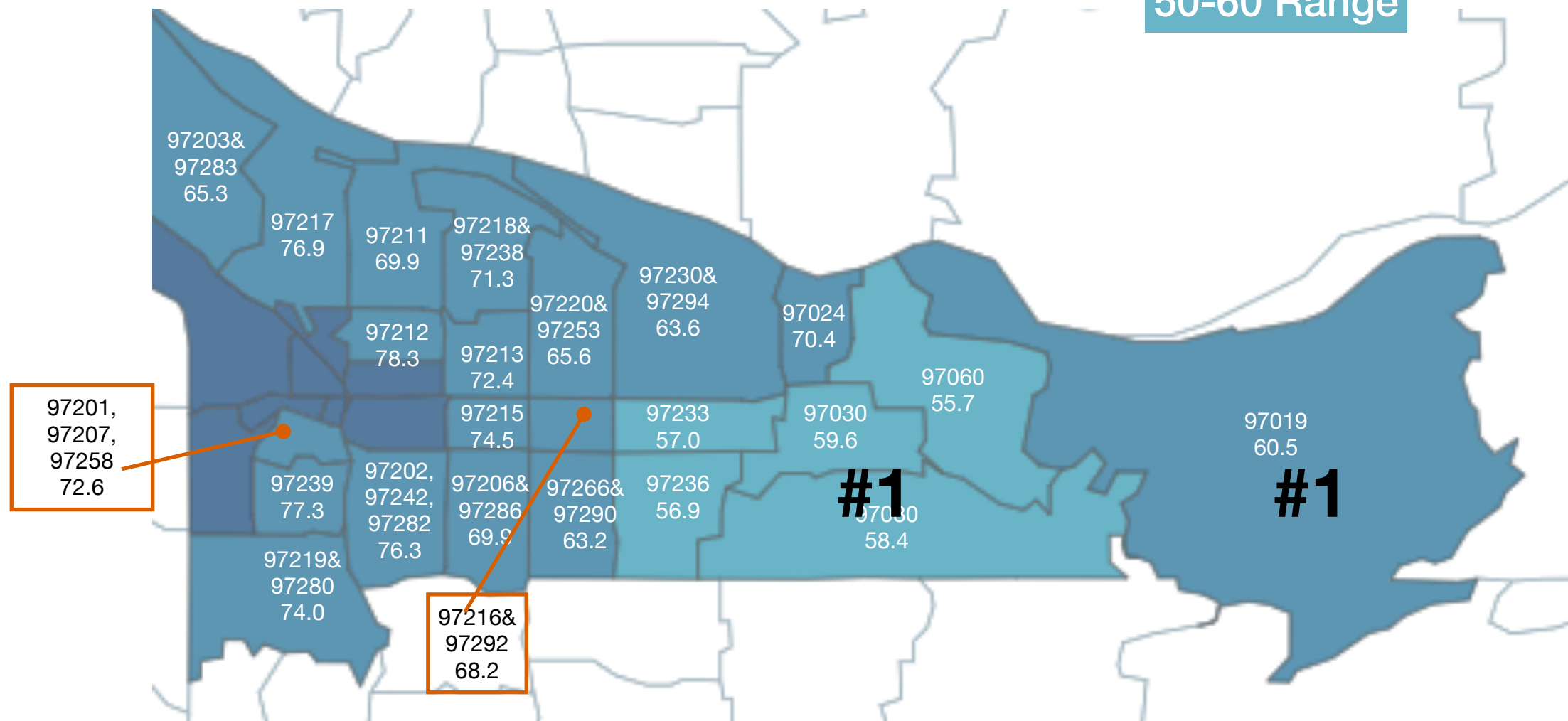

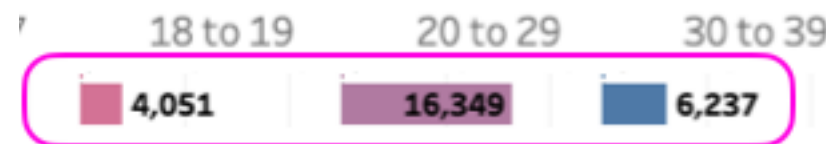


Legend: % total population vaccinated by ZIP code(s)

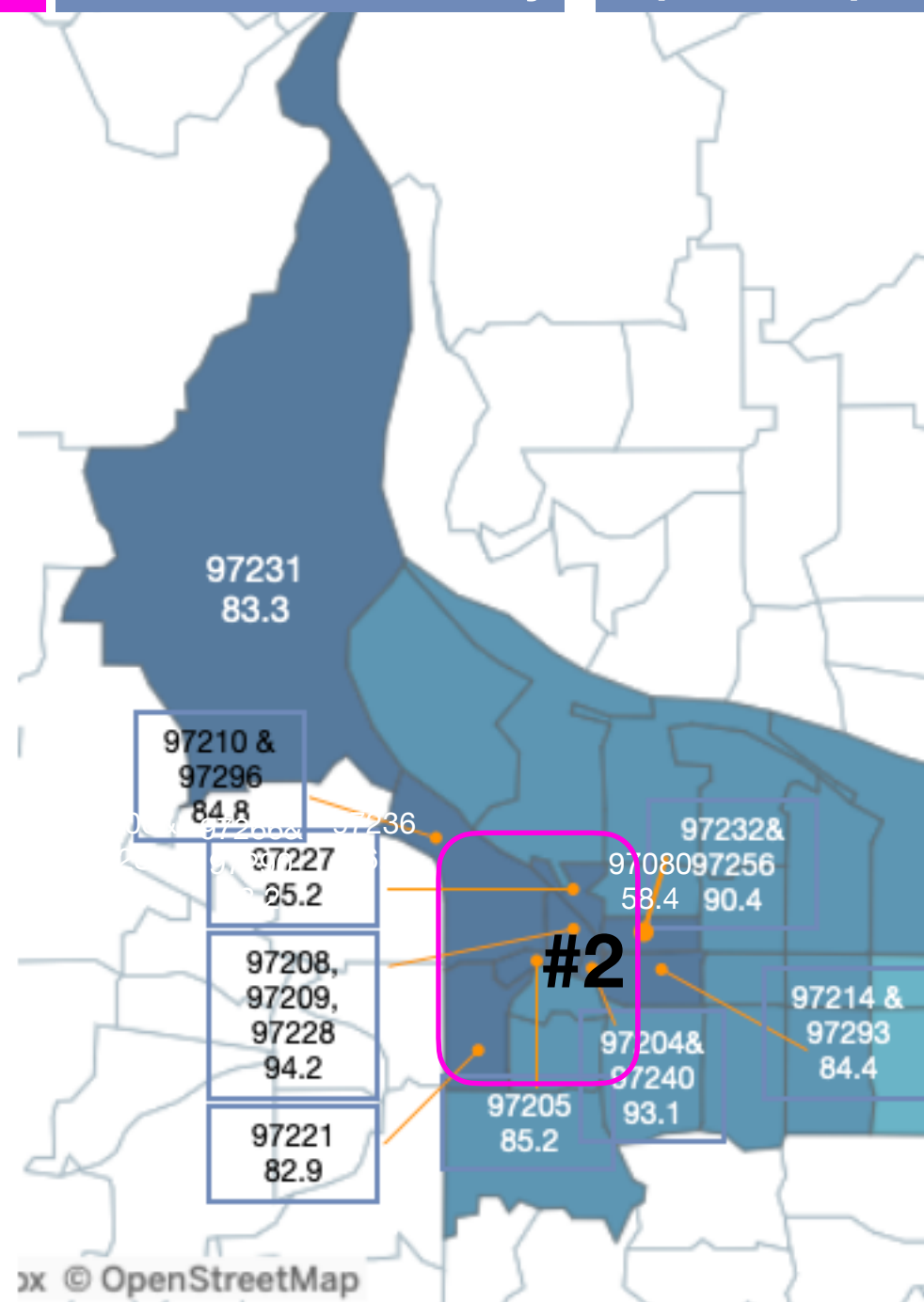

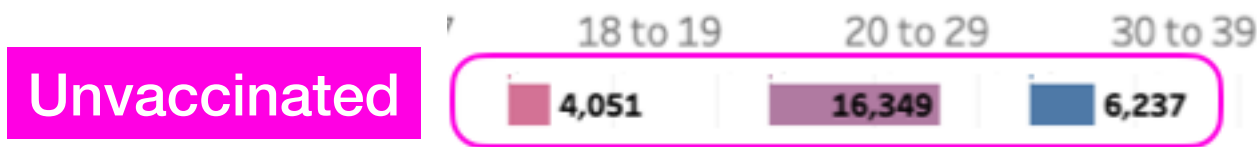

## Why your neighborhood bar or cafe might ask to see your vaccine card

### We can wait for the City and State to mandate or...

New York City requires **you** to be vaccinated against COVID-19 to enter this business

Those 12 years of age and older **must show proof of COVID-19 vaccination**

NYC VACCINE FOR ALL. SAFE. FREE. EASY. NYC

The policy, known as the **Key to NYC**, mandates that all facilities offering indoor dining (including restaurants, bars, nightclubs, and cafes), indoor fitness, or indoor entertainment (including movie theaters, performance venues, and museums) to require proof of vaccination for both staff and customers.

## **We can act now.**

**This is a call to the leadership in our neighborhoods with business districts, especially with businesses that appeal to young people such as is found in Old Town, Downtown, the Pearl and the NorthWest to incent these businesses to be **good neighbors** and emphasize why it is in their self interest and for the good of the community to ask for proof of vaccination as they now do for age as soon as possible.**

### **Note**

Only in a handful of states — Texas and Florida are the biggest — are private businesses prohibited from requiring proof of vaccination.
