





NYPD Has Just Under 3 Dozen Police Officers on Unpaid Leave

So far, only **34 police officers and 40 civilian police employees** have been placed on unpaid leave, he said. As of Sunday, about 1 in 6 police personnel were still unvaccinated.

According to Mayor <u>Bill de Blasio</u>, about 9,000 of the city's municipal workers were put on unpaid leave for refusing to comply with the COVID-19. About 9 in 10 city workers required to be vaccinated have received the vaccine, and there have been no disruptions to city services from staff shortages, de Blasio said.

The city of Portland is poised to fire 91 city employees for failing either to provide proof of vaccination or request an exemption by Oct. 18. They're being fired today, Oct. 19.

During the week of October 17 through October 23, there were 7,723* of COVID-19. 5,567 (72.1%) were unvaccinated and 2,156 (27.9%) were vaccine breakthrough cases. Source

The median age of breakthrough cases was 48 years. 69 (3.2%) breakthrough cases were residents of care facilities, senior living communities or other congregate living settings. 523 (24.3%) cases were 65 or older. There were 91 (4.2%) cases aged 12-17.

STONE: And while most breakthrough infections don't lead to serious disease, in some fraction of the population, they do, which is why the best solution for protecting the most vulnerable is to make sure everyone around them is also vaccinated.
